All stocks listed on the PNGX can only be bought and sold through a licenced stockbroker, who acts on your behalf to buy and sell shares for a fee. JMP Securities Limited is a licenced stockbroker.

## A. Investors wishing to buy shares:

For investors to wish to buy shares, our minimum Investment amount is PGK2,325.00 to buy shares in any company listed on the stock exchange.

The PGK2,325 minimum investment amount includes a fee of PGK325 which comprises of our brokerage fee, the PNGX fee and the Securities Commission Levy. The PNGX fee and the Securities Commission Levy are applicable to every trade.

Our brokerage costs are payable on a sliding scale with reference to the overall value of the trade. The chart below outlines our PNGX Brokerage Fees in detail:

K2,000 - K10,000	K325
K10,001 - K20,000	2.5% + K75
K20,001 - K50,000	2.0% + K75
K50,001 - K100,000	1.5% + K75

- If you are providing a photocopy of any other current valid ID that does not include a photo ID &/or signature, the photocopy must be in colour, and you must sign and date the photocopy next to the image of the ID.

- 2. A Buying Shares form this form authorizes us to purchase your shares

You will also be required to deposit the investment amount into our bank account as follows:

Please note that you do not need to return the completed "Buying Shares" form and make the required deposit when you return your completed application form if you have not decided on which stock to purchase on the local exchange.

Once all compliance obligations are met and your trading account has been opened, we will advise you of the same. You will then need to deposit the minimum investment amount once you have decided on which stock you wish to purchase and complete your "Buying Shares" form.

### B. Investors wishing to sell shares:

In the event you wish to sell shares you hold, and you do not have a current trading account with us, you will need to complete the following forms:

Once all compliance obligations are met and your trading account has been opened, we will advise you of the same. You will then need to provide the current Holdings Statement and complete your "Selling Shares" form once you have decided.
